REV. FR. CYRIL NORONHA shall be the Managing Trustee of the Trust and shall hold office until a new Trustee is selected for the said post by the BOARD OF TRUSTEES.

- For any act which is against the interest or objects of the Trust done by him willfully in spite of warnings by The Board of Trustees.
- For being absent from attending meetings of the Board of Trustees for a consecutive period of one year or more without availing leave from The Board of Trustees.

Before removing or expelling the Trustee for any of the cases mentioned above The BOARD OF TRUSTEES shall give him opportunity to be heard and pass a resolution removing him from Trusteeship.

The decision of the Managing Trustee shall be final and binding and shall not be called into question any where.

#### IX. THE POWERS OF THE TRUSTEES:

For the furtherance of the objects of TRUST and to discharge their duties in accordance with the objects of the Trust, the BOARD OF TRUSTEES shall have the following powers:-

1. To hold the Trust fund and all other funds, monies and property which may be received either by way of donations, subscriptions, gift, income, rent, interest, dividends or otherwise howsoever and all investments representing the Trust fund, subject to the powers, provisions, agreement and declarations hereinafter declared and continued concerning the same.
2. To apply or spend any portion of corpus or income of the Trust for purchasing land, buildings and other immovable or

X. A person shall cease to be a Trustee in any of the following events:

The BOARD OF TRUSTEES shall have as its members all TRUSTEES whether appointed by this indenture or co-opted, by the Managing Trustee. The Managing Trustee will act as chairperson of the Board meetings and conduct proceedings. In his absence, one of the TRUSTEES will preside over the meeting.

XIII. The funds of the Trust shall be invested in the modes specified under the provisions of section 11 (5) of the Income Tax Act 1961, as amended from time to time

#### XIV. AMENDMENTS TO THE TRUST DEED:

No amendment to the Trust deed shall be made which may prove to be repugnant to the provisions of Sec.2 (15), 11, 12, 13 and 80G of the Income Tax Act 1961, as amended from time to time. Further, no amendment shall be carried out without prior approval of the competent commissioner of Income Tax or any other concerned authority under direct tax laws in order that the Trust may retain the status of a Public Charitable Trust under Sec.11 of the Income Tax Act 1961 or analogous sections under similar other laws may be amended from time to time.

#### XV. DISSOLUTION CLAUSE:-

In the event of Dissolution or Winding up of the Trust, the assets remaining as, on the date of dissolution shall under no circumstances be distributed among the Trustees but the same shall be transferred to another charitable Trust whose objects are similar to those of this Trusts and which enjoys recognition, u/s 80G of the Income Tax Act 1961, amended from time to time.

XVI. The Trust formed shall be IRREVOCABLE.

XVII. The BENEFITS of the Trust shall be open to all irrespective of caste, creed or religion.
